## **1** Introduction

The Swedish banking market is adopting the international standard ISO20022 for payment messages. It will be a rollout over several years, and where we will develop new products and services around the credit transfer message for payments to bank accounts, Bankgiro numbers and Plusgiro numbers. It covers account transfers, bill payments, salary, pension, and social security benefits. Fully built, this new standard will improve integration with the international bank standards and benefit all our customers.

This document is a Message Implementation Guide for implementing usage of file reporting of account statements from Länsförsäkringar Bank. The account statement can be used to import all account transactions in a structured form to the customers system.

This version of the Message Implementation Guide describes the XML format CAMT.053.001.02 and how it is used by Länsförsäkringar Bank. Depending on type of transaction the amount of information will differ as Länsförsäkringar Bank has different information sets.

Incoming Bankgiro transactions which are booked on the account in one summarized transaction will be reported specifying all the included transactions.



## 2 Message Specification CAMT.053



In order to receive Account statements, the customer must subscribe to it. Once subscribed, they are sent to the customer in CAMT.053-format. The frequency can be chosen by the customer, but default frequency is once a day 7 days per week. An account statement will be produced regardless of if there are transaction to be reported or not. Opening balance and closing balance will be reported in the file based on calendar day period.

The statement will contain all monetary bookings on the account with detailed information (based on the information Länsförsäkringar Bank has received.

### 2.1 Document tag


Document tag is used to define the schema reference for the Camt.053 file. XML Schema or XSD is the xml document built to validate the attributes of an XML File. The XSD document will be shared for customers of the service to pre-validate the file in their own system before importing the file.

### 2.2 Group Header



The group header holds information about the whole CAMT.053 message. It will include a unique message ID and creation date and time.

### 2.2.1 Message ID

The **MsgID** element is the identification of the message. It will be unique and will be structured as Date plus BIC (ELLFSESS) plus running number.


### 2.2.2 Creation Date and Time

The date and time format in element CreDtTm is from ISO8601.

### 2.2.3 Message recipient

This will not be used by Länsförsäkringar Bank at the moment.

Each statement is connected to one account only. In the ISO 20022 standard each message can include several statements. Länsförsäkringar Bank will send one message per account if a customer has subscribed to CAMT.053 account statements for several accounts. This can be changed in the future.

### 2.3.1 Identification

The statement identification number will be the MsgID plus a running number for the statement within the same message.

### 2.3.2 Creation date and Time

The date and time format in element CreDtTm is from ISO8601.

### 2.3.3 From To Date

Under this tag there will be both a start date and time and an end date and time for the account statement. All transactions booked on the account between these two times will be reported in the statement.



### 2.4 Entry



There will be one entry per transaction booked on the account. On this level information regarding the booked entry on the account will be presented. Some of the more detailed information will be handled in the transaction details.

### 2.4.1 Entry Reference

This is a unique ID for the entry set by Länsförsäkringar Bank.

### 2.4.2 Amount

In this tag the amount of the entry will be shown.

### 2.4.3 Credit Debit Indicator

This tag holds information if it is a debit (withdrawal from the account) or a credit (deposit on the account). The codes are DBIT and CRDT.

### 2.4.4 Status

The status of the entry reported will always be booked (BOOK).

### 2.4.5 Booking Date

This will be the date which the transaction was booked on the account.


### 2.4.6 Bank Transaction Code

Set of elements used to fully identify the type of underlying transaction resulting in an entry on account. Länsförsäkringar Bank will use the code structure as per ISO to define the type of transaction that has been booked on the account. See appendix for list of codes used by Länsförsäkringar Bank.

### 2.4.7 Additional Entry Information

In this field Länsförsäkringar Bank will report transaction texts (which also is viewable in the Internet Bank).

### 2.5 Entry Details



In this block there will be more details of the entry. For summarized bookings there will also be details on group level in the tag Batch.

### 2.5.1 Batch


In this block there will be information if the transaction is part of a batch booked entry. There are three different types of information in this tag. For salary transactions (via pain.001 or salary list) batch information will be reported but no details.

- MessageIdentification will hold messageID from pain.001
- PaymentInformationIdentification will hold ID from the payment information part in pain.001
- NumberOfTransactions will be number of transaction details for this batch.

### 2.6 Transaction Details



For this block details regarding a transaction will be reported. For summarized booking on the account there can be many transaction details for one entry, for example for incoming Bankgiro transactions or batch booked transactions initiated via pain.001. For salary transactions the details regarding each transaction will not be reported , due to the sensitivity of the data. For reporting of details regarding salary transactions please see our camt.054 offering.

### 2.6.1 References

In this section there are several references included. Depending on type of transaction different references will be reported. For questions regarding a transaction to an officer in Länsförsäkringar Bank the best reference to use is the AccountServicerReference. This reference will be included also for salary transactions.

### 2.6.2 Amount Details

### 2.6.2.1 Instructed amount

Instructed amount will be reported for transactions in other currencies. It will be used for the amount in foreign currency.

### 2.6.2.2 Transaction amount

The transaction amount will always be included and will always be in the account currency (always SEK).

For transactions in other currencies currency exchange information will be reported under this tag.

### 2.6.3 Related Parties

Information regarding related parties if they exist and are allowed to be reported.

#### 2.6.3.1 Debtor

This is the party that has been debited for the transaction. Will normally not be supplied for outgoing payments (debits on the account) as this is the account owner.

For debits this will be mapped for the following payment types:

- Card transactions Merchant name if return
- File initiated payments from pain.001 file
- Debtor name from Swish message
- Debtor name for incoming Bankgiro payments
- Debtor name for incoming NCT transactions

### 2.6.3.2 Debtor Account

This is the account that has been debited for the transaction.

For Swish payments the Swish number will be reported here both for outgoing and incoming transactions.

For outgoing payments done from own Bankgiro number, the BG number will be reported here.

For incoming payments from Bankgiro number or Plusgiro number these will be reported.

### 2.6.3.3 Ultimate Debtor

This will be reported if included in outgoing or incoming message.

### 2.6.3.4 Creditor

This is the party that has been credited for the transaction. For outgoing payments this will be the name supplied by the initiator if applicable. For incoming payments this will be the name coming from the debtor if applicable.

For Swish transactions this will be the name connected to the Swish number.

For outgoing Bankgiro and Plusgiro payments that Länsförsäkringar Bank will collect from the Bankgiro and Plusgiro catalogues.

#### 2.6.3.5 Creditor Account

This is the account that has been credited for the transaction.

For Swish payments the Swish number NUMBER will be reported here both for outgoing and incoming transactions.

For incoming payments to own Bankgiro number, that Bankgiro number will be reported here.

For outgoing payments to Bankgiro number or Plusgiro number these will be reported.

#### 2.6.3.6 Ultimate Creditor

This will be reported if included in outgoing or incoming message.

#### 2.6.4 Related Agents

Only creditor agent used and only for outgoing Bankgiro and Plusgiro payments. For payments initiated via pain.001, the information in pain.001 will be reported here.

#### 2.6.5 Purpose Code

Purpose code sent with the transaction will be reported here if it exists.

### 2.6.6 Remittance Information

Under this tag Länsförsäkringar Bank will report the remittance information we have received from the initiator. It can be supplied as Unstructured or Structured remittance information.

#### 2.6.6.1 OCR numbers as structured reference

### 3.1 CAMT.053.001.02 Bank To Customer Statement

The XML structure matrix is divided into groups, so it should be easy to find different parts. Only the sections handled by LF in any way will show up here.

Some elements represent an exclusive choice between two or more child elements. These child elements are marked with XOR to indicate they belong to an XOR-split, where the choice of one element is mandatory. The multiplicity of an element is notated with an interval notation, like x..y, meaning x is the minimum number of occurrences of an element, and y is the maximum.
